

## NOTICE RE DECEMBER 23, 2024, CHAPTER 13 DOCKET

The court will conduct the Chapter 13 docket on December 23, 2024, by **telephone using the new Zoom audio conference hearing line**.<sup>1</sup> **ALL PARTIES WILL PARTICIPATE TELEPHONICALLY. ONLY COURT PERSONNEL WILL BE ALLOWED IN THE COURTROOM.**

Please note that the court has sorted the Chapter 13 docket by last name of the debtor's attorney<sup>2</sup> and divided the docket into three groups. A copy of that docket showing the **three groups** is attached and is also posted with this Notice on the court's website at <https://www.mow.uscourts.gov/bankruptcy>.
